Hi Eddie:

Thank you for your email below. I reviewed the two links that you sent me.

Regarding the first link, you may recall that MDPH did complete its evaluations related to the New Bedford High School, the Keith Middle School, and the neighborhood surrounding the schools. We presented the results to the school community and the neighborhood on September 27, 2011 at the New Bedford High School (in the afternoon) and at the Keith Middle School (in the evening). We prepared two reports on the results, that we released for public comment at that time. The two reports were then later finalized (and included responses to the comments received from the public).

Regarding these investigations at the NBHS and KMS and the neighborhood surrounding the schools, the first report, "Evaluation of Indoor Environmental Conditions and Potential Health Impacts, New Bedford High School" can be found on DPH's website at:
