The circumstances associated with this request have been investigated by the Department of Public Infrastructure, Wastewater Division. There was a burst underground water pipe at this location. As the water line break was underground, the leaking water did not enter the sewer system. All necessary repairs have been made. As the result of the investigation, I would recommend that a credit of \$610.05 be allowed.

Should you be in agreement, I would ask that you communicate the abatement recommendation to the City Council.
