

Dear Mayor Mitchell,

EMS will have projected deficit in the 400 account of \$ 30,000.00 for FY16. More specifically, it pertains to our medical supply budget line. This year we have seen an increase in call volume as well as some one time purchases that were needed to upgrade our ability to perform prehospital care to the standard of care. The EMS medical supply budget line also covers all the medical supplies for the Fire and Police department's first responder needs and also replenishes supplies for all the City wide AED's that are in place.

I would also like to rescind the initial request for the 200 account dated 3/29/2016 for the amount of \$55,000.00 dollars and replace it with the amount of \$35,000.00 dollars. Within the 200 account is our workers comp line, which can be difficult to predict and though injuries were down this year for EMS, we did have one employee last week have major knee surgery.
