Please be advised that the Department of Inspectional Services is currently maintaining the Vacant Building Registration Revolving Fund.

The purpose of the Vacant Building Registration Revolving Fund is to have money available to pay for the repairs and maintenance of vacant buildings, Surveys Board of Buildings that have to be demolished by Contractors we hire and pay for the demolition fee for services rendered, pay for the tipping fees for buildings demolished by the City crews. To reimburse the Department of Public Facilities for materials purchased to do any emergency board-ups out of this fund and to reimburse labor costs for said board-ups. The fund also supports the Mayor's Task Force with a budget for 2 Full Time Building Inspectors working 40 hours a week, one Full Time Administration Coordinator working 40 hours a week, one Full Time Clerk working 35 hours a week and a budget for office supplies.

The undesignated fund balance from FY15 is \$543,655.84 The anticipated revenue for FY16 is estimated at \$330,000. The estimated expenses for FY16 are \$123,835.00

The revenue for this account is generated by collecting fees for the Vacant Building Registration Ordinance and also the \$500.00 fee collected for the inspections fee. The anticipated revenue for FY17 from the registration/inspection fees should be approximately \$350,000.00

At this time I would like to request an operating budget of \$458,280.00 broken down as follows:

100 Account \$ 157,280.80

200 Account \$ 300,000.00

400 Account \$ 1,000.00
