Meeting called to Order at 9:00 AM Board accepted Minutes for July 7, Meeting

Mr. Amado mentioned to the Board about a Banker and Tradesman foreclosure report from May titled "Rising Foreclosures Continue in the Bay State For the 27th Consecutive Month". Mr. Amado noted that the article states that there was a 26.7 percent increase in foreclosure petitions filed in Massachusetts from 2015.

Upon inquiry from Mrs. Saunders, Mr. Amado informed the Board that about \$700,000 of the 1.2 million dollar overlay goes to exemptions.

Mr. Amado reminded the Board that the revaluation is still in progress and that Steve McCarthy, a field representative from DLS, was in New Bedford conducting a data quality study and will meet with Mr. Amado to discuss the findings. He also stated that the department should have an idea of what the final numbers will look like by the end of the month.

Mr. Amado informed the Board that that the Data Lister position is now being advertised both on the City of New Bedford website and on New Bedford Guide.
