Responding to questions from Chairman Beauregard, Mr. Gibau stated that he's been with the club for nine years and that he's served as an Auditor and the Treasurer, as well as serving as the manager of the 'club' in 2014; and that he also has experience working at nightclubs (Temptation), as well as several other bars; he also stated that he was T.I.P.S. Certified and that he's on site about 35-40 hours a week, which includes nights and weekends; and that there would not be any changes to the day to day operations of the club.

**Voted:** On a motion by Commissioner Almeida, the Board **voted unanimously to approve the petition as presented**, and to forward the application to the Alcoholic Beverages Control Commission for their approval; with the stipulation that Mr. Gibau submit a copy of his T.I.P.S. Certification to the Licensing Board office within thirty (30) days of receiving final approval or prior; and that all his servers be 'certified' as well, with copies of their certifications to be kept on file for review, if needed.

**Route Six Properties, Inc. d/b/a Temptation, Steven M. Camara, President**, who is requesting a **Change of Officers, Director, (New) Stockholder, and the Transfer of Corporate Stock of the Common Victualler (Restaurant) All Alcoholic Beverages License**; and the acceptance of his resignation as the President, Treasurer, Secretary, and Sole Director; and to allow the transfer of all his Corporate Stock (100%). The proposed transferee is also requesting a **Change of d/b/a to Club Déjà Vu and a Pledge of the Common Victualler All Alcoholic License to Steven Camara** with an address of **1134 American Legion Highway, Westport, MA.** as security to authorize and execute a promissory note in the amount of **Five Hundred Thousand Dollars (\$500,000.00)**, pursuant to **Massachusetts General Laws Ch.138 s.23**.

***Present: Atty. Patrick Matthews along with Kelvin Ortiz, Manager and Proposed New Owner***

Responding to questions from Chairman Beauregard, Atty. Matthews stated that Mr. Ortiz, who was previously approved as the manager, is now purchasing the business from Mr. Camara; and upon approval, will become the Sole Officer, Sole Director, and Sole Stockholder of the corporation; adding that Mr. Camara is now legally disabled and cannot work anymore, which necessitated this change; he also stated that the operation would be basically the same as it is now under Mr. Ortiz. He also stated that Mr. Ortiz has security in place and that all the bartenders and waitresses are T.I.P.S. Certified, as well as Mr. Ortiz; and that Mr. Ortiz is there as a full time manager, both days and evenings.

Atty. Matthews stated that Mr. Ortiz is trying to re-brand the establishment and to change the reputation to some extent, which is the reason for the name change to Club Déjà vu.

In discussing the selling price, Atty. Matthews stated that Mr. Ortiz is assuming some of Mr. Camara's outstanding debts, that is why there is no down payment, but as the pledge of license indicates, the debt will be paid off over time with the payments increasing over time based on the increase in revenue.

When asked by Chairman Beauregard if the purchase price included the property, Atty. Matthews stated that it did not include the property, which he stated was a rental property.

When informed by Chairman Beauregard that the ABCC might question the validity of the Promissory Note, Atty. Matthews responded, they might ... they may have questions about it ... but we'll be able to verify everything ... Mr. Camara has nothing do with this business any more.

When questioned by Chairman Beauregard if the weekly numbers were doable, Atty. Matthews responded, I know what you're saying ... but because this business was in such a hole ... that is why it's structured the way it is ... it's based on performance ... right now, it's going to be a challenge ... you're not wrong about that ... but restructuring the business this way ... is the only way to make this all work.

When Chairman Beauregard expressed his doubts that the payment numbers would work, Atty. Matthews responded, I don't share your pessimism ... I think we're a little more enthusiastic ... already since he's been managing ... a lot of things that were wrong there financially ... he's taking care of it ... vendors have all been brought up to date ... the DOR and DUA have been addressed ... each one on these problems ... Mr. Ortiz has addressed one after another ... we think this is doable with all due respect.

**VOTED:** Commissioner Almeida made a motion to approve the petition as presented; and to forward the application to the Alcoholic Beverages Control Commission for their approval. – Unanimous

**Lobo's Lounge, Inc. d/b/a Washington Square Package Store, Jose A. Lobo, President**, who is petitioning to **transfer a Retail Package Goods Store All Alcoholic Beverages License to Expo's Liquors, Inc. d/b/a Expo's Liquors**. Upon approval, Kyle Duarte will be the President, Treasurer, Secretary, Sole Director, Sole-Shareholder, and **Manager**. Premises will remain the same at **281 County Street**.

Final approval will require a **'Change of Tenant'** from the Building Department.

*Application has been advertised; Abutters Notification is not required.*

**Present: Atty. John Williams along with Kyle Duarte, Proposed Owner/Manager**

Prior to Chairman Beauregard opening the hearing on the application, Mr. Nanopoulos informed the Board that he had been notified by Mark Fuller, Assistant Treasurer, that the seller owed the City some back taxes, and requested that the Board, if they were to approve the application, stipulated that the back taxes would have to be paid before they grant their final approval of the transfer, once approved by the ABCC. (Mr. Lobo was in attendance, and acknowledged that he would resolve any outstanding issues.)

When Atty. Williams made the point that his client was not purchasing the property, Mr. Nanopoulos informed him that the request was being made due to the fact that the property owner (Mr. Lobo) was selling his liquor license.

Responding to questions from Chairman Beauregard, Atty. Williams stated on behalf of his client that he would continue to run it as Mr. Lobo has for years, and that his client currently is not T.I.P.S. Certified but he would be getting that done next week; adding that he's been running Expo's Variety Store down on Dartmouth Street for about six years, so he has experience in the retail industry; and he also has experience in checking I.D.'s for the cigarette sales of which they sell quite a bit of at that store. Chairman Beauregard stated the following as a point of information; I've been on this Board for twenty years ... and I've never had anybody put a sign and contact a liquor distributor ... prior to approval from this Board and the ABCC ... this will be the first ... it's never happened before.

**VOTED:** On a motion by Commissioner Almeida the Board **voted in the majority** to approve the application and to forward the application to the Alcoholic Beverages Control Commission for their approval with the following stipulations:

1. That the licensee completes an Alcohol 'Server Certification' course **within Thirty (30) Days** days after **final approval is received or prior**; and proof of your certification be provided to this office; and that all his employees be 'certified' as well, with copies of their certifications to be kept on file for review, if needed;
2. And that the current license holder, who is also the property owner, **be current on all his city taxes prior to the Board granting their final approval of the transfer of his liquor license to Expo's Liquors, Inc.**; and said proof be submitted to the Licensing Board office.

**7. PETITION - Trans. # 232 – Plot # 8--36**

**Kaitlyn Duarte d/b/a Expo's**, who is petitioning as an individual for a **New Retail Package Store Wine and Malt Only Beverages License**. The proposed licensed premises is a convenience store located on the first floor of a three-story building in an area approximately 1,316 sq. ft., which will include a walk-in cooler for the storage of alcohol, as well as coolers and shelving for the sale and display of alcohol; the area also includes two rooms for storage in the rear of the building. Alcohol will also be stored in the basement. There is one (1) entrance/exit in the front of the building, as well as one emergency exit located at the rear of the building. The premise is situated on the east side of Brock Avenue, between Charles and Aquidneck Streets, and will be numbered **332 Brock Avenue**.

Final approval will require a **'Certificate of Inspection'** from Inspectional Services.

**Present: Atty. Walter Frazee, Jr. along with Kaitlyn Duarte, Proposed Owner/Manager**

Responding to questions from Chairman Beauregard, Atty. Frazee stated on behalf of his client ... for several years Kaitlyn has operated a small convenience store in a building that's owned by her father on Brock Avenue ... it's a residential district ...

that doesn't have any package stores in it of any kind ... I know that right at the start of Brock Avenue ... there is one ... but this a very large geographic area ... totally underserved ... so ... she has been in the business for several years ... she's been running it ... she's very experienced in checking I.D.'s ... it's more difficult to buy cigarettes than it is to buy a bottle of beer ... so she's very well trained with all the protocols for checking and verifying I.D.'s ... she also posted a sign to see if there was support ... or even if there was any opposition to this ... in response ... she got a very large number of people who signed in favor of the petition ... there was no opposition ... nobody signed or said any word in opposition ... so we are confident that this is something that the neighborhood wants ... that they need ... and that they will be very well served ... so she has the experience ... this will be her full time job ... she spends approx. 50 hours a week at the site ... since her father owns the building ... so essentially it will be a family business ... owned solely by my client.

The Board voted unanimously to receive the petition that was submitted by Ms. Duarte and place it on file.

With no further questions from the Board, Chairman Beauregard then asked if there was anyone present who wished to speak or be recorded in favor of the petition, upon hearing and seeing none; Chairman Beauregard then asked if there was anyone present who wanted to speak or be recorded in opposition of the petition.

Upon hearing and seeing none, Chairman Beauregard closed that portion of the hearing and called for a motion.

Commissioner Craig stated that based on the fact that the nearest package store one was just over a mile and a half away and not in the area of this location, and that there was nothing within a half mile of that location, that he would second Commissioner Almeida's motion and vote in favor of issuing a new license at this location.

**VOTED:** On a motion by Commissioner Almeida the Board **voted in the majority** to approve the application and to forward the application to the Alcoholic Beverages Control Commission for their approval with the following stipulations:

1. That the licensee completes an Alcohol 'Server Certification' course **within Thirty (30) Days) days after final approval is received or prior;** and proof of your certification be provided to this office; and that all his employees be 'certified' as well, with copies of their certifications to be kept on file for review, if needed.

**Present: Jason P. Lanagan, Co-Owner**

Responding to questions from Commissioner Almeida, Mr. Lanagan stated that the renovations relative to the previously approved plans were just about done; and they hoped to be open by Thanksgiving eve; and that he was T.I.P.S. Certified and that his staff would be certified as well.

You **must submit** to the Board that evening, a letter stating your intentions regarding the license that has been issued to you detailing either an opening date, plans to transfer, or change of location, as it applies to your situation.

Please Be Advised that failure to appear before this Board as requested will result in "Automatic Revocation" of your Common Victualler All Alcoholic Beverages License.

**Present: Jason P. Lanagan, Owner**

Responding to questions from Chairman Beauregard, Mr. Lanagan stated that the bar side which has seating for 29 patrons was just about 100% complete and ready to open but the kitchen side still has substantial renovations and is about 20% complete; adding that the hood is up ... the fire grating is up ... the fire alarms work ... and that he still had to have some final inspections to be done ... it's been a while ... were trying to get open ... but it's a financial burden to get the kitchen open ... and not be open ... I think we would be able to get the kitchen open a lot quicker ... if we're open and generating some revenue ... there are also people waiting in the wings too ... they've been waiting for a while ... they're all T.I.P.S. Certified ... they're all experienced ... so that's where we are ... we're a couple of weeks away from being ready to open without the kitchen.

When asked by Chairman Beauregard as to when he anticipated that the kitchen would be ready, Mr. Lanagan responded, I would say about 6 months ... we still have to install a grease trap, which is a substantial cost ... purchase the equipment and get it up and running ... and we don't want to do it half way ... we want to do it the right way.

Chairman Beauregard responded, if we were to approve the opening and we have you back in November, you should be good to go; to which Mr. Lanagan responded, "Yes".

**VOTED:** On a motion by Commissioner Almeida the Board **voted unanimously** to allow Mr. Lanagan to open without an operating kitchen, with the understanding that the kitchen would be operational by the end of November; failure to have the kitchen operational by November will require the licensee to appear before the Board at that time.

#### **9. APPLICATION, Representation Required**

Whaling Blues Festival/Zeiterion Theatre, Justin LaCroix, Representative** who is requesting approval of an application for a **Special One-Day All Alcoholic Beverages License** for their '2016 New Bedford Whaling Blues Festival' to be held within **Fort Taber Park On The Great Lawn**; and to be held on **Saturday, August 13, 2016, from 11:00 a.m. until 9:00 p.m. (Site Plan & Security Plan On File)**

**Present: Justin LaCroix, Representative**

Responding to questions from Chairman Beauregard, Mr. LaCroix reviewed the layout of area being used within Fort Taber on the Great Lawn; he also stated that they were bring back the Blues Festival that hasn't been held in 10 years, and would be featuring local bands as well as big artists, and that the enclosed area would include a VIP Tent and a Concession Tent; and that they were hoping and planning for about 1,500 to 2,000 attendees, maybe a more from 11:00 a.m. until 9:00 p.m.

Responding to further questions from Chairman Beauregard, Mr. LaCroix stated that there would be three means of egress into the totally enclosed area; one would be an entrance/exit for the performers and staff; the second would be the main entrance/exit; and there would be an additional exit only gate; and that all three means of egress would have a Police Detail as well as event security and staff; and there would be additional security within the event area along with Police Details, which would be determined by Police Detail Officer; and that the alcohol would be served by the 'Z's T.I.P.S. Certified bartenders who they use at the theatre; and that the alcohol would purchased through Quality Beverages, whose looking to come in as a sponsor; and they will be delivering and picking up all the alcohol; and the I.D.'s will be checked by event staff and that wristbands will be issued.

**VOTED:** On a motion by Commissioner Almeida the Board **voted unanimously** to approve the security/site plan and the application as presented.

With regard to this year's event, this Board is looking forward to working with you and your committee with the hope that you embrace the outstanding plan that has formulated over the past several years, and that, if possible, explore ways to improve on the plan.

We fully anticipate that this year's committee will work with us to help ensure that the 102<sup>nd</sup> Feast of the Blessed Sacrament, which is very important to the Portuguese Community, the City of New Bedford, and to all that travel from afar to enjoy and partake in the celebration of the Madeira heritage, remains a safe and enjoyable event for all.

**PREVIOUSLY ADOPTED:**

- ✓ The Feast grounds perimeter that patrons will be traveling in and out of, which includes the 'Feast and the Carnival area' will be enclosed with only four (4) entrances/exits locations. (See Attached Plan)
- ✓ Each entrance/exit will be manned by Police Officers full time and they will be responsible for not allowing alcohol to leave that area.
- ✓ The Feast Committee agreed to hire five (5) additional officers for each night of the Feast, who will be used to contain the alcohol in the enclosed area.
- ✓ Post signs at all entrances & exits – "No Alcohol Beyond This Point".
- ✓ Set up barrels at all exits to help deter persons from leaving the contained area with alcohol.
- ✓ I.D.'s will be checked before issuing wristbands; also anyone consuming alcohol will be monitored to make sure they have a wristband and spot checks of person's with wristbands will be done to make sure they have proof of age on them.
- ✓ The Feast Committee has also agreed to keep nine (9) Officers an additional hour (until 2:00 a.m.) to provide extra security for the neighborhood and they will patrol the immediate neighborhood to ensure that those persons leaving the Feast Grounds do so in a timely manner with as minimal an amount of disturbance to the neighborhood as possible.
- ✓ They also have eliminated the 28 oz. containers of Madeira Wine, which will only be sold in 3 oz. & 7 oz. cups, which should eliminate some of the problems with intoxication and the consumption of the wine by minors purchased by persons of age. (New)

Chairman Beauregard once again stated his desire to see the alcohol contained within the fenced in feast grounds, by stating that this is the last weak spot we have, which is the sale of alcohol out onto Hathaway Street; and that is the place we have alcohol coming off the grounds and that is the only area where we don't have the control we would like to see.

He also stated that they're up to 475 T.I.P.S. Certified Servers and that **no one is allowed to serve alcohol on the Feast Grounds, unless they are T.I.P.S. Certified;** and that **they have four (4) Certified Trainers that belong to the club,** and we hold the classes at the club.

Responding to a question from Chairman Beauregard, Mr. LeConte stated that the former carnival area is completely fenced off; therefore, no one would be able to cut through that area; so they will have to exit by way of the top or bottom of Hathaway Street.

When asked by Chairman Beauregard if they had added any land for this year's event, Mr. LeConte stated that they hadn't but it was something they continue to work on but that's in the future.

Chairman Beauregard suggested that the changes that were discussed be adopted as part of the 2016 approval.

Chairman Beauregard once again commended those present for their continued commitment to keeping the 'Feast' a safe event for all, and for working with the Police Department and the Licensing Board to get to the point we're at today over the last thirteen years; and for listening and adopting those suggestions put forth by all who have participated in the process during that time.

Mr. Nanopoulos opened the hearing by reminding those present of the Board's prior decision, which included the stipulation, that if the application that was submitted at the last meeting for a change of manager was returned for "any" reason, the club would have to surrender their license until all outstanding issues were resolved.

When asked by Chairman Beauregard as to who would be speaking on behalf of the club, Mr. Morris offered the following response; since we last appeared before the Board ... a lot of things have happened ... we have received an offer to purchase the club ... which I brought with me (It was an offer that was submitted to Jeff Pontiff from Mr. Robert Xifaras) ... we have a meeting scheduled for tomorrow night, so that we can put it before the Board ... and if they approve it ... it would then go before the general body on July 10<sup>th</sup> for a vote to approve the sale.

Ms. Finni added, we're expecting another offer in a couple of days.

Chairman Beauregard responded to the offer that was shown to the Board by stating, just for the record ... this has happened before with this proposed purchaser ... another licensee also came in with an offer sheet from this person ... and it didn't go anywhere ... so I would question if this paperwork goes anywhere .

When asked by Chairman Beauregard as to what their plans are now, Mr. Morris responded, we've also assigned Atty. Joe Michaud with Power of Attorney to help resolve our tax issues ... getting that information for us ... and he's contacted the Department of Revenue to get those numbers.

Ms. Finni added, she was informed by Linda Morad (St. Anne's Credit Union) that at the point of sale ... and she has done this before ... there would be an agreement to pay all the taxes and other debts right then and there by the bank ... and that the offer that is being presented would be enough to cover all of that.

Mr. Ventura responded to Ms. Finni's comments by stating, we don't know if that offer is legit or not ... you know the person ... you know the situation ... but again, it is an offer ... it is there ... but if he can come up with the financing ...



we don't know that yet ... Atty. Michaud is going to look into that ... we've given him Power of Attorney ... in order to make sure that everyone is paid ... so we're trying to get to a number so that at the end of the day ... everyone is paid off ... all the creditors ... all the taxes ... everything is paid ... and hopefully, maybe with a little leftover for the members ... we don't know that ... so that's kind of where we are ... so what we're trying to do at this point ... is just keep the lights on ... so we don't have an empty building ... and pay the gas and electric ... and keep the tenants that we have upstairs with the lights on ... the mortgage is paid up to this point ... we're currently on a 12:00 a.m. closing at this point ... we have no bands except on Tuesday ... as far as I know ... there have been no problems with the police ... I don't think there's been any problem with the neighbors to this point.

Chairman Beauregard responded, the problem you have is that you don't have an approved manager of record ... due to your outstanding DUA issues ... we can't get the new manager approved by the ABCC ... until such a time that those issues are resolved.

Mr. Ventura responded, the problem is ... we can't resolve those issues until we have the sale.

Mr. Nanopoulos interjected; you can't transfer the liquor license until those issues are resolved.

Mr. Ventura responded, we need about thirty days ... so we can get this thing resolved ... we do have another offer that we think is coming in ... we have another meeting with the members on July 10<sup>th</sup> ... but it has to be sold ... and believe me ... we're not making any money closing at 12 a.m. ... it's very ... very minimal ... it's the mortgage ... and gas and electric ... Comcast ... but again ... we have two tenants that we're concerned about.

When asked by Mr. Nanopoulos if Atty. Michaud had made a recommendation to them about the situation, Mr. Ventura responded, No, he just said to come here tonight ... and he thought you'd take the license tonight ... and that I expressed to him that I was hoping to get a continuance ... so we would have time to get these things resolved ... and Donna is meeting with him tomorrow on the Power of Attorney issue.

Chairman Beauregard responded, I understand what you're saying ... but you have to be mindful when we met last or the meeting before ... that we said that the matter had to be rectified in order for us to approve a manager ... and if not ... we would have to take the license ... and that's where we are right now.

When asked by Mr. Morris, how can we hire a manager now if we're going to be selling the club?

Chairman Beauregard responded, you can't ... I said that three meetings ago ... that I didn't want to approve it then ... because I know you couldn't do what you were trying to do.

Commissioner Craig responded, what we did is ... we extended you a courtesy to allow it to go as far as it did without a manager ... and it's impossible for you to get a manager approved until you resolve all those other issues ... and there have been issues up there with a manager ... there is debt ... there have been other issues up there ... so how can we allow you to operate without an approved manager ... now you don't have a manager ... it's impossible for us to allow you to continue.

Mr. Ventura responded, all we're looking to do is to keep the lights on ... again ... I don't even know if this is even a legit offer or not ... but if it is and we get this thing resolved ... it could be a smooth transition ... so what we're looking for is a 30 day extension.

Ms. Finni stated that she's spoken to the proposed buyer (Mr. Xifaras) and he's looking to get this done.

Mr. Nanopoulos offered the following to the timeline to the Board; no matter who applies ... an application would have to be submitted complete by July 7<sup>th</sup> for the Board's July 25<sup>th</sup> meeting ... and today is June 27<sup>th</sup> ... so you're talking 11 days to get an application in ... then it takes 6 to 8 weeks for that application to be approved by the ABCC ... without any outstanding issues ... and right now ... it wouldn't go through ... as soon as they get it ... it would be denied for the same DUA issues ... as it did with the manager's application ... it's not going anywhere ... you're asking for 30 days ... but if that application isn't in by July 7<sup>th</sup> ... it's not 30 days ... it's much longer than that.

Mr. Ventura responded, what he (Mr. Xifaras) is proposing is that he get in there by September ... he's looking to come in and makes some renovations to the building ... again ... my biggest concern is the tenants that are upstairs.

Chairman Beauregard responded, I hear you ... but I think we're beating a dead horse ... as I'm sitting here ... and I'm only one of three votes ... I don't see how we can make this work for you after tonight ... I really don't.

Commissioner Almeida stated that he agreed with his fellow Board members and felt that the Board had extended it long enough, and that it would be his motion to suspend the license immediately until such a time that all outstanding DUA issues are resolved.

When asked by Mr. Nanopoulos if they were in a position to resolve their DUA issues, Mr. Ventura stated that they did not have the money to do so at this time, and they would only be able to resolve them as a result of the sale of the club.

In response, Commissioner Craig stated, there have been other places where people from the club put their own cash up to resolve their issues with the DOR and DUA, and were later reimbursed by the club; they were in the same situation as you.

Mr. Ventura responded that there wouldn't be any member that would do that, since everybody has walked away.
