Board accepted Minutes for July 21, Meeting

Mr. Amado stated that he spoke with Steve McCarthy, a field representative from DLS who was in New Bedford conducting a data quality study. Mr. Amado stated that Mr. McCarthy believes the results look good and a few minor things have to be discussed.

Mr. Amado informed the Board that the department is in the process of the final checks for the sales analysis, and will begin to look at values and produce reports.

Mr. Amado mentioned a July 2016 article from Banker and Tradesman titled "MA Home Prices Hit Record Highs". He read that the article states the median sale prices of single family homes and condominiums reached record highs of \$372,000 and \$345,000 respectively, which may be indicative of a seller's market.
