Dear Mayor Mitchell:

In accordance with Massachusetts General Laws, Chapter 44, §53E ½, the revolving fund under the control of the New Bedford Fire Department known as the Community Training Fund (Fund #1212) whose purpose is to provide the following:

- Digital & print media for training purposes and for advertisement of classes
- Nonperishable training equipment & supplies (training AEDs, mannequins, airway equipment, etc)
- Perishable training equipment (BVMs, dressings & bandages, gloves, OPAs, triangle bandages, etc)
- Subscription renewals to training services (24/7 EMS)
- Training DVDs
- AHA student course manuals for any AHA class
- AHA course completion cards for any approved course
- Salaries & Wages
- Office supplies and office equipment used in conjunction with managing the Community Training Center (ink, ink cartridges, paper, etc)

These items are to be used for community training purposes, whose revenues and amount limited to be spent were estimated at \$1,200.00 for Fiscal Year 2017. This is a new fund and since the department has been very successful in managing it, we are requesting a mid-year increase from \$1,200 to \$5,000.
