SUBJECT: Late File – Free Cash to FY 2017 Budget

As you know, the FY 2017 budget requires the use of \$700,000 in Free Cash to balance to the approved tax levy, due largely to changes in State aid that were instituted subsequent to the adoption of the City's budget and to the allowable booking of bond premiums per the Municipal Modernization Act. We were recently informed by the State that the assignment of Free Cash to the FY 2017 budget will require a vote by the City Council. The alternative would be to revise the approved levy, which would mean an additional increase to the tax rate.

In order to ensure that the FY 2017 budget is funded as intended, I respectfully request the submission of the attached order as a Late File for the December 8, 2016, City Council meeting.
