Mr. Amado stated that the Commissioner of Revenue has reached a potential settlement with Verizon of New England. The settlement would apply to appeals between Fiscal Year 2010 to Fiscal Year 2016. He also stated that the agreement would include a system of valuation to continue to Fiscal Year 2022. The Board voted in favor of support to the settlement with Verizon of New England.

Mr. Amado informed the Board that several ATB cases have been scheduled for January 25th, 2017 and February 1ST, 2017.
