NEW BEDFORD Layout No. 8532

WHEREAS, the Department of Public Works, acting on behalf of the Commonwealth of Massachusetts, did, under date of August 6, 1969 (Layout No. 5815) lay out and take charge of as a limited access State highway, a road in the City of New Bedford, County of Bristol, being known as Route 140, and said Department, did, under date of April 17, 1986 (Layout No. 6618) alter a portion of said State highway, all as shown on the plans of said State highway on file in the office of the Massachusetts Department of Transportation copies of which plans have been filed in the office of the County Commissioners of said County of Bristol, or their successors, if any, and in the office of the City Clerk of said City of New Bedford; and

WHEREAS, it now appears advisable to revise the limited access provisions of said State highway and to establish a "Line of No Transit".

NOW, THEREFORE, acting under the provisions of Chapter 6C and Chapter 81,

Section 7C of the General Laws, as appearing in the Official Edition thereof, and acts in

amendment thereof and in addition thereto, the Massachusetts Department of Transportation

adjudges that public necessity and convenience require said Department should alter the location

of said State highway, and should lay out and take charge of said State highway, altered, with limited access provisions, as hereinafter described.

The Mount Pleasant Street baseline extension begins at a point, shown on the plan as station 78+94.84, said point being identical as station 78+94.84 of the Mount Pleasant Street baseline of the aforesaid April 17, 1986 (Layout No. 6618) State highway alteration of said Route 140 at Mount Pleasant Street, and extends thence N 27°10′11" W 555.16 feet to the point of ending thereof, as shown on the plan as station 84+50.00 and the stations hereinafter referred to are points thereon.

The alteration consists of revising a portion of the limited access provisions of the aforesaid State highway location, insofar as applicable to the location line thereof, established by the aforesaid August 6, 1969 (Layout No. 5815) State highway layout of Route 140 in the location more particularly described as follows:

Free access to and egress from the State highway location is hereby allowed for authorized vehicles only across the easterly location line of the aforesaid August 6, 1969 (Layout No. 5815)

State highway layout of Route 140, as follows:

Between a point thereon bearing N 62°49'49" E and being 40.00 feet distant from station 82+53.84 of the Mount Pleasant Street baseline extension, as hereinbefore described, and a point thereon bearing N 62°49'49" E and being 40.00 feet distant from station 82+83.84 of said baseline.

A line of which transit is not allowed is hereby established within the aforesaid August 6, 1969 (Layout No. 5815) State highway layout of Route 140, and is more fully described as follows:

The line across which transit in not allowed is hereby established within the limits of the aforesaid State highway location, beginning at a point on the westerly location line of the aforesaid August 6, 1969 (Layout No. 5815) State highway layout of Route 140, said point bearing N 62°49'49" E and being 40.00 feet distant from station 81+49.22 of the Mount Pleasant Street baseline extension, as hereinbefore described, and extends thence, leaving said location line N 62°49'49" E 132.27 feet; thence N 27°10'11" W 281.00 feet; thence S 62°49'49" W 132.27 feet to the point of ending thereof, again on the westerly location line of said 1969 layout, said point bearing N 62°49'49" E 40.00 feet distant from station 84+30.22 of said Mount Pleasant Street baseline extension.

The above described access-egress item and the Line of No Transit are more particularly shown on the plan to which reference is hereinafter made.

The State highway hereby altered and laid out is shown on a plan signed by the Chief Engineer and signed by the Massachusetts Department of Transportation, Highway Division and on file in its office, said plan being entitled:

DECLARED: That said way as altered, as described herein and as described and shown on said plan, be and the same is hereby laid out and taken charge of by the Commonwealth; that the Secretary to the Massachusetts Department of Transportation shall file, in the office of the County Commissioners of the County, or their successors, if any, and in the City Clerk of the City in which said way is located, certified copies of said plan and copies of this certificate, signed by the Director, Right of Way Bureau, attesting that the Department has laid out and taken charge of said way as altered, in accordance with said plan, together with a copy of this adjudication.
