

SUBJECT: Public Safety Vehicles

As you know, there is a continuing need to bring the City's public safety vehicles into a serviceable condition. This effort has been aided substantially over the past two years by the purchase of front-line vehicles for the Police Department, two squad vehicles for the Fire Department, and the implementation of scheduled replacement programs for the City's fire apparatus and ambulances.

The FY 2016 budget includes \$100,000 in the Police Department for replacement cruisers. In addition, the Assessors' Office recently released \$300,000 from the 2007, 2008, and 2012 Overlay accounts. The combined \$400,000 will allow the City to fulfill two important needs:

- 1. The purchase of six patrol vehicles for the Police Department will replace two that were damaged beyond repair and four that date to 2003. The continuing replacement program will ensure that the City's front-line fleet is generally replaced over a three to four year cycle.
- Four of the Fire Department's command vehicles would be replaced by means of a twoyear lease purchase. The four vehicles to be replaced have an average age of nearly 17 years, and two of the four current vehicles were recently placed permanently out of service.

This ten-vehicle package will ensure the continuation of effective response capability going forward, and is particularly timely, given the upcoming winter. I respectfully request that the proposed overlay transfer be submitted for the September 24, 2015, City Council meeting.
