Mr. Amado informed the Board that the preliminary certification has been approved and that the FY 2017 Proposed Property Values will be published on the City's website. In addition, he stated that books with the proposed values will also be available for review at the public libraries from October 28, 2016 to November 4, 2016.

Mr. Amado informed the Board that the Parcel Lookup function on the City's website will not have updated values until January, after the final bills go out in the end of December. He stated that there will be an increase of the overall valuation of approximately 4%. Mr. Amado mentioned that he is now working on the levy in preparation of the Classification Hearing, which will determine the tax rate.

Upon inquiry from Mrs. Saunders, Mr. Amado informed the Board that interviews for the Data Lister position have not yet started.
