Santos, President, who is petitioning to transfer a **Common Victualler (Restaurant) All Alcoholic Beverages License** to **El Mexicano, Inc. d/b/a Mi Antojo Mexican Restaurant**. Upon approval, **Grisay Rojas** will be the President, Treasurer, a Co- Director, and a Co-Shareholder (50%); and **Javier Rojas** will be the Secretary, a Co-Director, a Co-Shareholder (50%), and the **Proposed New Manager**; the proposed transferee is also requesting approval of a **Pledge of the Common Victualler All Alcoholic License** to **Vila Franca Do Campo, Inc.** with an address of **554 Brock Avenue, New Bedford, MA.** as security to authorize and execute a promissory note in the amount of **Seventy-Five Thousand Dollars (\$75,000.00)**, pursuant to **Massachusetts General Laws Ch.138 s.23**. There is one entrance/exit onto Nelson Street from the dining room, one entrance/exit onto Second Street from the bar, and an entrance/exit onto Second Street from the dining room. The street level building is situated on the corner of Nelson and Second Streets, and is **numbered 601 South Second Street**.

Final approval will require a 'Change of Tenant' from the Building Department, a new 'Food Permit' from the Health Department, and a copy of 'Proof of Liquor Liability'.

1. PETITION - Trans. # 02733 - Plot # 47--37

Moby Dick Brewing Company, Inc., David Slutz, President, who is petitioning to **Change the Description of the Common Victualler (Restaurant) All Alcoholic Beverages** license to include an outdoor patio area approximately 370 sq. ft. (37' X 10') to be used as a 'Sidewalk Café', which will be enclosed with 21" high planters that will be used to rope off the described area, and will be used for seated dining purposes only.

The enclosed area, which will include three (3) tables with seating for Eighteen (18) patrons, will be located on the north side of the building, which is contiguous to the licensed premises. The proposed outdoor area will only be accessible by way of an entrance/exit through the restaurant located in the front of the building, and will be accessible by 'Hostess Seating' only; the area will also be monitored by the hostess and waitstaff at all times. The proposed hours of operation are **daily from 11:00 a.m. until 10:00 p.m., at which time all outdoor activity must cease, and shall be in effect from May 1ST through October 30th**, in accordance, and as specified in the City of New Bedford Sidewalk Café Permit Ordinance. (Ord. Ch. 15, Article VI, sec. 15-100 (B) (Item #'s 8 & 15). The licensed premises will remain numbered **52 Union Street**. The applicant is also requesting the approval of **Timothy G. Cleland**, who resides at **8 Atlantic Street, Plymouth, MA. as their new manager**.

Application has been advertised; Abutters have been notified.

Present: Atty. Christopher Saunders along with Timothy G. Cleland, Proposed New Manager

Chairman Beaugard opened the hearing on the petition by stating the Board would take the request by the applicant for sidewalk seating, and then they would consider the request for a change of manager.

Responding to questions from Chairman Beaugard, Atty. Saunders stated on behalf of his client that the main entrance would be on the west side of the building on Water Street and that the sidewalk café would be accessible only by the entrance/exit on Union Street, as indicated on the plans that were submitted; adding that the only way people will be able to access the outdoor seating area would be by "hostess seating", which would require patrons to enter through the entrance on Water Street and walk through the restaurant to the exit onto Union Street into the sidewalk seating

Atty. Saunders prefaced his further remarks by stating that he had a conversation with Mr. Nanopoulos regarding the procedures that needed to be followed for final approval, which includes approval from the Historic Commission and the Planning Board. Continuing his comments, Atty. Saunders stated, what we're proposing tonight is basically a 10' x 37' sq. ft. area for seating for 18 patrons ... although it's not depicted on the plan ... the dimensions (width) from the building itself to Union Street is 18 1/2 feet ... so we are roughly 10 feet from the building, which will leave another 8 1/2 feet from what I would call our proposed boundary ... which yet has been decided and approved by the Planning Board and Historical Commission ... what we're proposing is similar to what they had across the street at 37 Union Street (Pier 37) ... outdoor planters ... with some type of material that will clearly establish where this seating is ... we don't know what type of seating we're going to have in terms of the construction of the tables and the planters ... and that will be determined by the Historical Commission as to what is suitable and then we have to go to planning to have this approved ... if we don't get the approval from Planning ... irregardless of what this Board decides ... we won't be able to do it ... but one of the criteria is that when we go to Planning ... what is the order that you go ... so what we're looking for is conditional approval subject to Historical approving whatever type of seating they tell us we need and what type of plantings we need ... but it is our intentions to have plantings similar to what they had across the street ... and the Ordinance requires you to have from the planters to the street ... at least 4 feet ... and we have at least 8 1/2 feet ... so we're double as to what is required ... and the Ordinance also requires ... if you're serving alcohol in this area ... you're required to have a minimum of 6 feet ... we have 10 feet... so we do meet the dimensional requirements ... and we'll to what the requirements are ... and it will be for dining not just for the consumption of alcohol ... there will not be any people just standing out there ... we have 18 ft. ... the proposed hours are until 10:00 p.m.

Upon listening to Atty. Saunders' proposal, Chairman Beaugard stated, the only recommendation that I would make ... and it's more in terms to Planning and to the Historical Commission ... since it's a corner lot ... that there would be some type of ... and I'm not suggesting some type of jersey barrier ... but some type of baluster or some type of heavy planters on the corner there ... if there was ever an accident on that corner and you're sitting there ... you're a sitting duck ... literally.

Atty. Saunders responded, if that was the Board's position ... you could certainly make a recommendation ... and we could take that to the Historical Commission and the Planning Board.

Chairman Beaugard responded, I think it's something that you can bring up before those two bodies as a suggestion by this Board on that northwest corner, but I don't think it needs to be an official recommendation from this Board; to which Atty, Saunders responded, I think that makes sense ... but we certainly don't have the authority to do that without approval from the city ... but that certainly makes sense; to which Chairman Beaugard responded, if they say no ... they say no, I'm not going to hold it against you but I think it would be in everyone's best interest if there was some type of barrier on that northwest corner. Responding to further question from Chairman Beaugard, Atty. Saunders stated that there would not be any entertainment, music, or sound speakers outside; Chairman Beaugard also suggested that they use plastic cups outside.

With no further questions or discussion on this portion of the petition, the Board moved on to the Change of Manager portion of the petition.

Responding to questions from Chairman Beauregard, Atty. Saunders stated that Mr. (Richard) Lafrance is the current manager listed on the license, and that they were requesting approval of Timothy Cleland as the new manager; adding I've been before this Board many times and I don't think I've been before the Board with someone who has as much experience as Mr. Cleland in being a general manager.

Atty. Saunders added, he's been the General Manager of various restaurants in the Boston area, as well as in Foxborough and Pembroke ... he can certainly tell you of his experience ... he's going to be at the premises greater than 40 hours a week ... this is his fulltime job ... and that he would be on site on Friday and Saturday evenings.

When asked by Commissioner Almeida if he was T.I.P.S. Certified, Mr. Cleland stated that he was and that all of his staff would be as well within 30 days of opening their doors.

When asked by Chairman Beauregard as to when they planned on opening their doors, Mr. Cleland stated that March 14th is slated to be opening day with some mock service planned before then.

Chairman Beauregard responded, it's an eerie time to open a new business with St. Patrick's Day three days away, to which Mr. Cleland responded, indeed, I am hoping to have the weekend prior to that just to get the kinks worked out.

Chairman Beauregard warned Mr. Cleland to be careful, to which Mr. Cleland responded, absolutely!

Voted: Commissioner Almeida made a motion to approve the petition as presented and to forward the application to the Alcoholic Beverages Control Commission for their approval; with a stipulation that the Historical Commission and Planning Board approve their request; along with the stipulation that Mr. Cleland submit a copy of his T.I.P.S. Certification to the Licensing Board office within thirty (30) days of opening or prior; and that all his servers be 'certified' as well, with copies of their certifications to be kept on file for review, if needed. – **Unanimous**

VOTED: Commissioner Almeida made a motion to take up **Item #'s 2 - 7** at one time; waive reading; and approve the applications as presented – **Unanimous**

Responding to questions from Chairman Beaugard, Mr. Saker stated that he’s been in the car business for about 7 years and that he currently works for the Boch Dealership Group as a Finance Manager in Norwood, MA. and that this would be the first time on his own; adding that this was the former Capitol Motors location.

When asked by Chairman Beaugard if he would be doing his own repairs on site, Mr. Saker stated that he would not and that the garages would not be used for repairs. (**Note: Repairs are not allowed on the premises per Inspectional Services due to the fact that there are no MDC Traps on the premises.**)

When asked by Chairman Beaugard as to how many cars he was looking for, Mr. Saker stated that he was looking for twenty-five (25) as previously approved by Inspectional Services.

When asked by Chairman Beaugard if he would be storing any junk cars on site, Mr. Saker responded, absolutely not! Councilor Morad spoke in favor of the petitioner stating that Mr. Saker will be living on the property so I think there won’t be an issue with regard to keeping the lot neat; and that Mr. Saker has been proactive with the neighbors, so I don’t think there will be any problems.

VOTED: Commissioner Almeida made a motion to approve the application as presented pending receipts of all necessary documents; and to approve the license for the display of twenty-five (25) cars, as previously approved by Inspectional Services – **Unanimous**
