The Board voted to exempt the Community Preservation Act (CPA Surcharge) for the following parcels: 28-145; 36-361

Mr. Amado informed the Board that a decision was received from the ATB in the case of Schick v. New Bedford. An overvaluation amount of \$40,300 was granted.

Mr. Amado also informed the Board that a motion to dismiss the ATB case of Ciano v. New Bedford was granted last week.

Mr. Amado mentioned to the Board that the letter to be submitted to City Council for the adoption of the Cost of Living Adjustment (COLA) along with the order for Clause 17 and Clause 41 is ready and that the Board needs to approve a motion.

The Board voted to recommend and submit to the City Council to adopt the annual increase in the exemption and asset limits under Clause 17, and the increase in the income and asset limits under Clause 41, based on the cost of living adjustment determined by the Commissioner of Revenue to be 1.48%.

The Board congratulated Mr. Amado on receiving the 2018 Registration of Assessing Officers.
