Executive Board meeting called to order by Chairman Joe Cavalho: 12:14p.m.

Joseph Carvalho-Chairman - Announcements

A motion was made by Kelly Pawluczonek and seconded by Dr. Vaillancourt to approve March Executive Board meeting minutes as written. Unanimously passed.

Elaine said budget looks good. She is waiting for budget modification #3 from DPH regarding shelter supplies. Elaine reminded everyone that only individuals acting in an Emergency Planning role can receive money for cell phone payments now. She had to redefine 24/7 list by highlighting the individuals with cell phones from PHEP. Elaine asked EB if they would like her to make cell payment. Dr. Vaillancourt made a motion for Elaine to make cell phone payment. Kelly seconded. Passed.

Executive Board went into Executive Session at 12:30pm to discuss contractor positions. Contractors, as well as Regional Coordinator stepped outside the room during this time.

Budget discussion followed. The EB recommended the following:

The communications line item be kept the same but may need to be modified (Elaine and Joe will adjust according to DPH guidelines)

Budget for MHOA will remain the same as last year. Members are encouraged to attend.

MAHB will not use funding of \$1,000.

Yankee Conference-\$1,500

MAPHN-\$2,000. Will remain in budget with possible budget modification if not 50% of course offerings are not EP. Coalition Project on Closed PODS-\$3,500 will be earmarked in the training line item to present regional trainings. Regional Coordinator and planners will plan trainings.

Heather made a motion to allow EB Chairman, Joe Carvalho, to speak with Elaine on budget. Kelly seconded. Passed.

Joe announced recommendation of EB to recontract current contractors with a 2% raise. The EB will present recommended budget to Coalition members. The full budget will be voted on this afternoon at coalition meeting.

Deni announces that Larry Perry is now in Stoughton and Janiece Bruce, PHN will attend coalition meeting today and will be participating in Emergency Planning.

EB meeting adjourned at 1:34pm.
