Sofia Piedade appeared before the board stated on January 25, 2017 found multiple violations in the apartment and to her knowledge none have been corrected.

Felix Nwaobasi, owner appeared before the board and stated wants to correct all violations but cannot with tenant in apartment. He requested that the tenant move out due to damage to apartment. Mr. Nwaobasi rented apartment to only the tenant that is there now but realized after that she had her children and boyfriend living there too. Mr. Nwaobasi mentioned the apartment is too small for more than one person. States will fix violations as soon as tenant moves out.

Dr. Andrade stated as the landlord of the property he is responsible for the apartment. Also mentioned that there is an option of a pre-rental program.


