Ethics Disclosure

Dear Mayor Mitchell,

Enclosed for filing with, and approval by, the City Council is an ethics disclosure from Daniel Patten. The disclosure is required because Mr. Patten is the Treasurer for the Housing Authority and will be working after hours as Treasurer for the New Bedford Regional Refuse Management District.

As New Bedford Housing Authority Treasurer, Mr. Patten is considered a municipal employee of the City of New Bedford for purposes of the state's Ethics Law under M.G.L. Chapter 121B§ 7. As such, he must file a disclosure with the City Council, as required by M.G.L. Ch. 268A, § 20, that he is contracting with the New Bedford Regional Refuse Management District of which the City of New Bedford is a member.

The disclosure is required because he will have a financial interest in a contract with the City as a parttime, after-hours treasurer of the Regional Refuse Management District while at the same time technically being an employee of the City by virtue of his position as full-time treasurer of the Housing Authority. Such a financial interest is prohibited unless the disclosure notifying the City Council of the financial interest is filed, and the City Council approves the financial interest.

Mr. Patten has complied with the various conditions attendant to this engagement and has received the blessing of the Ethics Commission to proceed with his new part-time, after-hours, employment pending approval of the disclosure by the City Council. The Solicitor's Office concurs with the opinion of the Ethics Commission that the prospective employment is lawful, subject to approval of the disclosure by the City Council.
