**5. 83 Seymour St., Request for Hearing Re: Minimum Housing Violation Order #40607; Sean Hargraves, owner 83 Seymour St., New Bedford; Sofia Piedade, Sanitarian, present;**

Sandy stated that Sofia Piedade should be here in about 10 minutes. Sandy stated Sofia went by the property today and bird houses were gone.

Mr. Hargraves read his letter to us regarding the issue of birdfeeder and bird seed spillage from repeated complaint calls from Mayor's office.

Sandra Manning stated all we ask is that he keeps the area of bird feeder clean and if possible put some kind of tray under the bird feeder to prevent any animals that come around and feed off the spillage on ground. She also explained to the neighbor that a lot of issues had been taken care of and if we did not find any harborage for rodents then we could not right up a correction order regarding that matter but we explained to neighbors that if they could maintain the area then there wouldn't be no cause for harborage.

Dr. Andrade commented that first a citizen has the right to put a bird feeder on their property and second as a citizen you do have to be aware of what you're doing on property and third that you cannot control wild animals outside.

Dr. Longo also stated he thinks it is important to investigate any kind of complaints and if there are signs of rodents obviously it needs to be addressed but this is not the case here.

Sofia Piedade appeared before the board and stated the neighbor is mostly concerned about the pigeons and at this point there are only three still in area there use to be more.

Dr. Andrade stated we addressed this problem today and that this is a closed issue.


