Relative to their 7:00 PM, October 12, 2017 Meeting and related Meeting Agendas and Notices, the NEW BEDFORD CITY COUNCIL violated the Massachusetts Open Meeting Law (M.G.L. c. 30A, sec. 18-25; & Attorney General's Regulations – Open Meetings 040 CMR 29:00).

Meeting notices must be posted in a legible, easily understandable format; contain the date, time, and place of the meeting; and list all topics that the chair reasonably anticipates, 48 hours in advance, that will be discussed at the meeting. The list of topics must be sufficiently specific to reasonably inform the public of the issues to be discussed at the meeting.

Meeting notices must also indicate the date and time that the notice was posted, either on the notice itself or in a document or website accompanying the notice. If a notice is revised, the revised notice must also conspicuously record both the date and time the original notice was posted as well as the date and time the last revision was posted. Recording the date and time enables the public to observe that public bodies are complying with the Open Meeting Law's notice requirements without requiring constant vigilance. Additionally, in the event of a complaint, it provides the Attorney General with evidence of compliance with those requirements.

If a discussion topic is proposed after a meeting notice is posted, and it was not reasonably anticipated by the chair more than 48 hours before the meeting, the public body should update its posting to provide the public with as much notice as possible of what subjects will be discussed during the meeting. Although a public body may consider a topic that was not listed in the meeting notice if it was not anticipated, the Attorney General strongly encourages public bodies to postpone discussion and action on topics that are controversial or may be of particular interest to the public if the topic was not listed in the meeting notice.

Relative to the meeting in question, in violation of the Open Meeting Law, the NEW BEDFORD CITY COUNCIL posted three separate meeting notices, titled as follows: "City Council Calendar," "Consent Agenda" and "Late File Agenda." Each agenda contained different discussion topics, did not provide the time or location of the meeting, and did not provide the date and time that each agenda and notice was posted. Moreover, the said meeting notices and agendas were not drafted in an easily understandable format. These all constitute separate and distinct OML violations.

Open, transparent and accountable government is of paramount importance. When a public body violates the Open Meeting Law as outlined above, it is detrimental to the public interest and a breach of the public trust.

What action do you want the public body to take in response to your complaint?

In a timely fashion, the public body should take immediate remedial action via seriously addressing and completely correcting the violations that have been pointed out. It should also take concrete measures to ensure that the stated OML violations do not occur again. All votes & actions taken at the meeting in qustion should be declared null and void. Finally, all members of the public body and its staff should be mandated to undergo verifiable Open Meeting Law training within sixty (60) days.
