The Committee voted, on a motion by Mr. Livramento and seconded by Mr. Amaral, to accept the following School Committee meeting minutes as follows: (Supporting documents labeled "3")

Mr. Cotter abstained from voting on the minutes from 9/21 & 11/16, 2015.

Superintendent's Report (Dr. Durkin):

(Supporting documents labeled "4")

Dr. Durkin briefly explained that the MCAS 2.0 test results would be made public within the week. She continued that it is a very different test – not PAARC, not MCAS and comparisons cannot be made. No level (1-3) accountability designations will be used accept for a Level 3 designation for low participation (under 90%) and low graduation rate (67%). All standards will be aligned and the tests will reflect that. New Bedford High School will continue to administer the older MCAS "Legacy" test through 2018 with level designation continuing as well.

To a question by Mr. Amaral, Dr. Durkin explained that this is more like a "re-set" year. The PAARC test prepared the district in taking the new test as MCAS 2.0 is a more difficult test.



Interpreting the Projected Results (Part 1)

- * The results do NOT mean that students learned less; the next-generation MCAS measures in a different way
- * Remember: 2017 is the baseline year the first year of a new assessment - and we expect scores to change over time, as occurred when the legacy MCAS debuted in 1998.
- Massachusetts educators set these standards, and they raised them in order to make sure our students will be college- and career- ready.
- In some grades and subjects (grade 4 English language arts and math, grade 7 math), the percent of students Meeting Expectations will likely be similar to the percent that were Proficient previously. In other grades and subjects (grade 8 English language arts), the percent who are in Meeting Expectations will likely be lower than the previous percent of

Mayor Mitchell thanked the team for their hard work and asked if they received feedback that they otherwise may not have had. Ms. Coelho claimed that it was a fruitful "outside eye" but many recommendations came from the high school's own self-study.

Mr. Amaral commented that he felt highly positive and felt pretty confident as NBHS shined in the report with good news and optimism.

Mr. Livramento commended the NBHS staff and asked if there is priority in regard to the recommendations. Ms. Coelho stated that planning is always in the works with teams and committees working regularly to prepare for the next visit. She continued that there is a plan to add more teachers to serve ELL students.

To a question by Mr. Oliveira, Ms. Coelho stated that they were aware of all the recommendations that were made and not surprised by any of them. Mr. Oliveira also commended Ms. Coelho and her staff for their work.

Mr. Cotter extended his compliments as well to the staff of NBHS noting that that the commendations from the NEASC Committee outweighed the recommendations.

Mr. O'Leary stated that the FY19 budget planning has begun. MUNIS training is being offered as well and the Administrative Cost Agreement (ACA) with the city is being reviewed as part of the preliminary planning of the annual budget.

Dr. Finnerty arrived at 7:15.

In response to a question by Mr. Livramento, Mr. O'Leary explained the revolving fund process.

Mr. O'Leary also stated that the Jacobs School will be completed within the month and will be ready for the opening on November 27.

Mr. O'Leary reviewed the personnel report with the Committee. He reported that there were 51 appointments, seven retirements and 27 resignations since the last personnel report in September. There are currently eight classroom vacancies district-wide.
