Dear Council President Morad and Honorable Members:

I respectfully submit the enclosed communication from Dr. Patricia Andrade, Chairperson of the New Bedford Board of Health, pertaining to the appointment of Damon Chaplin as Director of Public Health. The Board has requested that I submit for the Council's consideration both a one-year waiver of residency and appointment at Grade M-16, Step 3. Mr. Chaplin plans to relocate his family to New Bedford, and the one-year waiver will allow him time to properly plan and execute that transition.

At an open meeting for the New Bedford Board of Health the Board interviewed for the position of Director of Public Health. The board unanimously selected Damon Chaplin, 126 Myrtle Street, Brockton, MA for this position.
