It has been difficult for NBEMS to compete with the smaller Fire Departments in the area who are able to offer higher wages and group 4 retirements. In December of 2016 we lost 5 paramedics to area departments, and just this past December we have lost 3 paramedics and 1 basic EMT to outlying departments. Having said that, when hiring employees for EMS positions, we always follow City hiring practices and give preference to New Bedford residents that are qualified for the position. Paramedic licensure is not a quick and easy certification to obtain. On average it takes an individual 2 years to complete classroom and clinical requirements and then once that is completed they can then sit for their National tests, both written and practical. 
