Attached, for your review, is correspondence related to the above referenced sewer abatement request.

The circumstances associated with this request have been investigated by the Department of Public Infrastructure, Wastewater Division. As a result of the investigation, space heaters stopped working causing pipes on the third floor to burst and flood the apartment. The water poured out of these pipes causing significant damage to the building, especially the ceilings. None of the water that came out of these pipes made its way back into the collection system. I would recommend that a credit of \$2,647.48 be allowed.

Should you be in agreement, I would ask that you communicate the abatement recommendation to the City Council.


