RE: Cannabis Zoning Appeal

Dear City Council President Linda Morad and the Council Members,

We request an immediate repeal of the decision to deny our zoning request to establish a premier recreational cannabis multi-purpose facility at 161 Popes Island, New Bedford, MA. We have been vocal since July 2018 in regards to our concerns pertaining to the city ordinance in relation to the state buffer zone laws. The state has established a mandated 500ft buffer zone between K-12 schools and cannabis businesses ONLY (excluded are residential areas, parks, churches, day cares, cemeteries, monuments, memorials, etc...). We are seeking an appeal of the decision implemented by Danny Romanowicz to deny our request to operate recreational cannabis businesses from 161 Popes Island. We believe the zoning ordinance established by the New Bedford City Council will impose an unnecessary hardship on our ability to open and operate a sustainable business (in a high volume area). Under our Economic Empowerment Certification with the Massachusetts Cannabis Control Commission the guidelines suggest that areas of disproportionately effected communities can not have any restrictions imposed on them that will make the process of opening harder. By New Bedford imposing zoning bylaws that supersede the stipulations outlined by the state it is doing a grave disservice to the spirit in which our EEC was granted by the state, our potential business as well as the community who voted to legalize the adult recreational cannabis market.

On 10/17/18 we submitted certified letters to all abutters within 300ft of 161 Popes Island; which included a package submitted to The City of New Bedford, Marine Park, 131 William St., New Bedford, MA 02740 (additionally notice was submitted to the City of New Bedford Planning Board, City Clerks Office as well as to the Honorable Mayor Jon Mitchell). We did not receive formal or informal opposition from any department to the location. It was our understanding of the Marine Park that it was


simply used as a city owned parking lot; as the verbiage on the sign says "Popes Island Marina (please see attached photograph)." Our business will not operate in such a way as to interfere with the Popes Island Marina (as it is additionally listed on the City of New Bedford site when a google search is performed as well as from the Popes Island Marina website and the Destination New Bedford webpage; please see attached).

We ask that the Honorable Members of the New Bedford City Council honor the cities representation of the Popes Island Marina (boat slip cost begins at \$90 per foot) and do not unjustly impose the zoning ordinance as pertains to parks and playgrounds. Moreover, we ask that the city hold steadfast to the commitment made during the Cannabis Licensing and Zoning Board meeting (10/22/18) where it was discussed that the city of New Bedford would take into consideration the states EEC program as New Bedford is one of the 29 disproportionately effected communities listed by the states Cannabis Control Commission.

Thank you for your consideration and we look forward to working with New Bedford as we establish the premier recreational cannabis facility.
