The Committee on Finance at a Meeting held on Monday, February 11, 2019, considered a COMMUNICATION, Mayor Mitchell, to City Council, submitting ORDERS transferring FREE CASH to STABILIZATION FUND in the amount of \$1,150,000; OPEB TRUST FUND in the amount of \$455,000; POLICE DEPARTMENT, CAPITAL OUTLAY in the amount of \$500,000; FACILITIES AND FLEET MANAGEMENT, CAPITAL OUTLAY in the amount of \$175,000; DEPARTMENT OF PUBLIC INFRASTRUCTURE, CAPITAL OUTLAY in the amount of \$300,000; FACILITIES & FLEET MANAGEMENT, CHARGES & SERVICES in the amount of \$235,000; FACILITIES & FLEET MANAGEMENT, CAPITAL OUTLAY in the amount of \$125,000; MIS DEPARTMENT, CAPITAL OUTLAY in the amount of \$150,000 and DEPARTMENT OF PUBLIC INFRASTRUCTURE, CAPITAL OUTLAY in the amount of \$50,000. To PUBLIC INFRASTRUCTURE, CAPITAL OUTLAY in the amount of \$300,000, Passed on a Roll Call Vote of Yeas 8, Nays 0; 1e. To FACILITIES & FLEET MANAGEMENT, CHARGES & SERVICES in the amount of \$235,000, Passed on a Roll Call Vote of Yeas 8, Nays 0; 1g. To MIS DEPARTMENT, CAPTIAL OUTLAY in the amount of \$150,000, Passed on a Roll Call Vote of Yeas 8, Nays 0; 1h. To PUBLIC INFRASTRUCTURE, CAPITAL OUTLAY in the amount of \$50,000, Passed on a Roll Call Vote of Yeas 8, Nays 0. Councillor Gomes was not present for the votes.
