Recommendation of Elizabeth Lydon for Associate City Solicitor position Re:

Dear Mayor Mitchell:

As you know, the Solicitor's Office has an Associate City Solicitor vacancy due to the retirement of Attorney Shannon Shreve. In January, First Assistant City Solicitor Jane Medeiros Friedman and I interviewed six candidates to fill this vacancy. Following these interviews, I am recommending that we hire Elizabeth Lydon for the position and that we request a residency waiver from the City Council and authorization to hire Elizabeth at the pay grade of M-12, Step 3.

Elizabeth is currently a Hearing Officer at the Department of Public Utilities (DPU), and prior to attending law school, she served as a regulatory officer at the Cape Cod Commission. These positions, along with her service on various municipal boards, have provided Elizabeth with a unique blend of experience that will enable her to take over much of Shannon Shreve's portfolio, which included energy, zoning and planning matters, and to assume additional responsibilities.

Elizabeth has worked on numerous complex matters that are relevant to the city, such as renewable energy projects, electric vehicle initiatives, municipal aggregation, commercial development, and comprehensive wastewater management plans. She has expertise in the Public Records Law, Open Meeting Law, and the Conflict of Interest Law. As a private citizen, Elizabeth served on the Wareham Conservation Commission, Wareham Wetland Bylaw Subcommittee, and the Wareham Zoning Bylaw Subcommittee.

Elizabeth lives in Rochester and will need a residency waiver in order to work for the city. Although we interviewed three New Bedford residents for the position, Elizabeth's relevant experience surpasses that of all of the other candidates, and we believe that she is the candidate who will best be able to work immediately on various city matters without requiring additional training.

We are also requesting that Elizabeth be hired at the pay grade of M-12, Step 3. Even if she is hired at this pay grade, Elizabeth will be taking a very substantial pay cut to work in the Solicitor's Office. Hiring her at the M-12, Step 3 level would make her pay commensurate with that of other attorneys in the Solicitor's Office with similar years of legal experience, and her salary would not be higher than any other attorney in the Solicitor's Office.

We therefore recommend Elizabeth Lydon for the Associate City Solicitor position and respectfully request your approval of this recommendation. I note that I will be out of the country and unable to attend the City Council meeting on February 28, 2019, but Jane Medeiros Friedman will be able to attend that meeting with Elizabeth, should her candidacy be on the agenda.
