Dear Mayor Mitchell:

I am requesting that \$40,000.00 be transferred from the Zoo's 100 level Salary and Wages account. The Zoo is expecting to end the year with a surplus in the 100 level due to a prolonged veterinary vacancy and the elimination of one budgeted education specialist position. The education position has been transferred to the Zoological Society. I am requesting that the transferred funds from the 100 level be distributed as follows: \$17,857.42 to the 200 level to cover unexpected consultant veterinary, legal, and workman's compensation claim costs, \$14,000.00 to the 400 level to cover unexpected animal food supply costs, and \$8,142.58 to the 800 level to cover a payment as outlined in the financial agreement between the City of New Bedford and All American Investment Group for the lease/purchase of the ultrasound machine for the Zoo's veterinary hospital. Although the 800 level lease originally was to be spread out evenly over three years, financial challenges in the last fiscal year resulted in the need to delay the receipt of the machine thus requiring that two payments be made in this fiscal calendar.
