Dear Mayor Mitchell:

I am requesting that \$7,000.00 be transferred from the Zoo's 400 level account to its 200 level account. The Zoo is expecting to end the year with a surplus in the 400 level due to the mild winter, a lack of major equipment repair, and cost savings measures that were implemented over the last three months. I am requesting that the transferred funds be distributed as follows: \$2,000.00 to the 200 level Veterinary Costs expense line to cover unexpected veterinary costs, \$4,000.00 to the 200 level Hospital/Medical expense line related to a new workman's compensation claim, and \$1,000.00 to the 200 Postage expense line to cover increased costs associated with the shipment of laboratory samples for external analysis.
