**RE: REQUEST TO TRANSFER FUNDS**

Dear Mayor Mitchell,

The New Bedford Police Department is anticipating a surplus in the 100 account Salaries and Wages in the amount of approximately \$500,000. This surplus is due to numerous vacant positions.

We have two servers that are failing, and on the verge of collapsing. These servers are utilized for our camera systems, which, as you know we have made significant in the past four and half years. The servers maintain data for our central booking area, all three stations as well as other locations, maintaining this information is in protecting the Department as well as the city from false claims and allegations of misconduct.

Respectfully we request a transfer into the 800 account of \$40,000 so we can replace both servers as soon as possible.
