Dear Mr. Higgins:

I am in receipt of your complaint, dated November 18, 2020, in which you allege that the City Council's Committee on Finance violated Open Meeting Law during its meeting of November 18, 2020. I apologize for my delayed response to your complaint, which was a regrettable oversight on my part.

In your complaint, you have raised the following issues:

- 1. "Chairman Joseph P. Lopes did not make the required announcement of who the members of the public body were that were participating remotely as required by the Open Meeting Law Determinations 2020-138 and 2020-98." - 2. "Chairman Lopes did not use the required roll call votes on all votes taken by the public body as required when any member of a public body participates remotely."

In response to these alleged violations of Open Meeting Law, please allow me to offer the following statements:

- 1. Upon reviewing the video via the link above, it is my understanding that on November 18, 2020, Chairman Lopes did recognize each attending member of the Committee on Finance. However, I may be misunderstanding your concern. If you feel that I am incorrect, please feel free to contact me directly at 508-979-1449.
- 2. With regards to your complaint that Chairman Lopes did not take roll calls on all matters during said meeting, you are absolutely correct. Instead, voice votes were taken and recorded for most, if not all, of the votes during that meeting. This error was due to the Council being unaware that roll calls are required for each and every vote while members participate in remote meetings. As a result of this information coming to light through your complaint, this practice has been corrected and all votes of the Council and its Committees are now being taken by roll call; and this shall be the practice for all future meetings in which members participate remotely.

On behalf of the entire City Council, I thank you for your time and attention to this response and wish you continued success in this new year.
