
COVID-19 Overview

Since January 2021, COVID-19 case rates have improved significantly across the commonwealth. Key COVID-19 health indicators for New Bedford have dropped significantly over the last three months and just over 2 million doses of COVID-19 vaccines have been administered in Massachusetts.

COVID-19 New Bedford Public Schools

As of March 11, 2021, K-12 educators, child-care workers and school staff were made eligible to receive the COVID-19 vaccine. By April 5, 2021 all elementary school students will be expected to return to in-person learning. New Bedford Public Schools have already begun the process of transitioning to full in-person learning and will continue with a phased-in approach throughout the rest of the year.



New Bedford COVID-19 Weekly Vaccine Allocations

Since January 4, 2021, the New Bedford Health Department has been receiving weekly allocation of COVID-19 vaccines from the Massachusetts Department of Public Health (MDPH)--please see below. The vaccine allocation amounts for New Bedford have varied from week to week, depending on the target population, vaccine availability and eligible cohorts. Since January 11, 2021, The New Bedford Health Department has administered over 3500 COVID-19 vaccines to eligible residence and seniors living in New Bedford.

Vaccine Equity Initiative:

The MDPH has recently designated 20 cities and towns as health equity communities, and New Bedford is among those listed. The Baker-Polito Administration launched this outreach initiative in the 20 cities and towns (Boston, Brockton, Chelsea, Everette, Fall River, Fitchburg, Framingham, Haverhill, Holyoke, Lawrence, Leominster, Lowell, Lynn, Malden, Methuen, Randolph, Revere, Springfield and Worcester) most disproportionately impacted by COVID-19. This initiative was created to support enhanced awareness, create equitable distribution of vaccines and work with vaccine equity communities to provide additional resources. One of the resources made available through this equity initiative was the capped allocation of vaccines for equity communities. New Bedford is currently receiving a capped allocation of 600 doses per week.

COVID-19 vaccine outreach and education:

In addition, MDPH has also contracted with ASG/Health Care for All (HCFA) to provide COVID-19 education and outreach support to vaccine equity communities. More specifically, ASG and HCFA will work with DPH liaisons and community/municipal leadership to assess needs for hyper-local, population-specific communication and outreach, tailor messages and materials, assess where more resources are needed for community partners, and provide feedback to DPH to inform future public health decisions. A boots-on-the ground approach will include door-to-door canvassing in the 20 communities as well. We recently received an additional allotment of 200 vaccines dedicated to New Bedford residents living in low-income housing. The City of New Bedford should anticipate a significant increase in vaccine allocations as national supplies continue to increase.

COVID-19 In-Home Vaccine Program:

Lastly, The New Bedford Health Department recently partnered with the MDPH to implement an In-Home Vaccination program for individuals who would not be able to be vaccinated unless they receive the vaccine in their home. It does not include populations that are temporarily homebound and/or are able to leave the home with adequate assistance. The New Bedford Health Department will continue to advocate for more vaccines and increased autonomy within the vaccine distribution pipeline, to ensure equitable distribution of vaccine resources to its most vulnerable populations.

Massachusetts Provider Allocation

Weekly allocations are subject to change based on federal availability, demand from providers, and obligations to meet second doses. Providers have 10 days to use their doses. The federal government is providing inadequate supplies to meet the demand of our provider community or our residence. Therefore, the vaccine distribution process has been streamlined with first dose requests prioritized to:

New Bedford COVID-19 Vaccine Data Report

The MDPH recently released their <u>weekly vaccine data report</u>. This weekly data set includes information on individuals vaccinated for COVID-19 by city or town. The data set below includes age, race and ethnicity characteristics of vaccinated individuals in Greater New Bedford. Due to our limited supply of vaccines and large volume of seniors living in New Bedford, we have dedicated a majority of our vaccine resources towards inoculating our senior population. As a result, seniors over the age of 65 represent the cohort with the highest percentage of fully vaccinated individuals in New Bedford at 16.32 %. In addition, this number increases significantly to approximately 42%, when we include individual seniors who have either received at least one vaccine dose and/or have recently tested positive and recovered from COVID-19. However, this chart also shows significant disparities within our Hispanic/multi-race populations with a vaccination rate of only 1.26 percent according the MDPH weekly vaccine data report.
