The program and purpose of the fund "whose purpose is to cover Program Monitors, administrative support, program instructors, program support and supplies for programs, and facility improvements to the Andrea McCoy Recreation Center and capital expenses whose revenues and amount limited to be spent for FY22 is restricted to revenue deposited into the fund."

Estimated revenues FY21 \$19,500

Revenue source(s) fees from recreational programs and rental of the Andrea McCoy Recreation Center

Amount estimated to be expended in FY22 \$52,500 of which \$33,000, (three thousand three hundred dollars) is a portion of the undesignated fund balance.

The requested \$52,500 will cover the daily operations of the AMRC and associated recreational programs, and the following improvements to the Andrea McCoy Recreation Center:

- Construction for the redesign of the Andrea McCoy Recreation Center entrance to make it more secure for staff and members using a design from Mount Vernon Group for secure access point Approx. \$33,000
