I am writing in response to the CFO's request for information pertaining to the Revolving Fund that is operated and maintained by the Clerk of Committees. The information requested is as follows:

- 1. The purpose of this revolving fund is to properly advertise and notify abutters of Special Permit Hearings, which are held in the Committee on Appointments & Briefings.
- 2. Approximately \$5,000.00 should be credited to this revolving fund for FY22.
- 3. Individuals, corporations, or other such parties seeking special permits are the source of these funds.
- 4. It is estimated that there will be approximately \$5,000.00 that again goes through this fund in FY22. However, this number is based solely on the information we have on hand from past years, and could be slightly or even dramatically different. There was not a lot of activity for this fund in FY21.
- 5. The Clerk of Committees' Office maintains operation and control of Revolving Fund #1240.
