Dear Honorable Members of the City Council:

The Committee on Finance at a Meeting held on Monday, September 13, 2021, considered a COMMUNICATION, Mayor Mitchell, to the City Council, submitting a request to hire the Department of Resilience and Environmental Stewardship's Environmental Project Manager, Courtney Cohen, at Grade M-12, Step 4 to compensate her commensurate with her expertise and decades of relevant experience. Dear Council President Lopes and Honorable Members:

I submit for your consideration a request to hire the Department of Resilience and Environmental Stewardship's selected candidate for the position of Environmental Project Manager, Courtney Cohen, at Grade M-12, Step 4 to compensate her commensurate with her expertise and decades of relevant experience. A detailed justification for the request from Director Michele Paul is attached to this communication. In sum, it is not feasible for Ms. Cohen and her family to relocate to New Bedford from Dartmouth, and the recently enacted ten percent pay reduction for non-residents would prevent Ms. Cohen from accepting the position. As she is the most qualified candidate to emerge from an exhaustive search, I respectfully request that you agree to on-board Ms. Cohen at the higher step, so that her salary would be roughly equivalent (two percent lower) to the Step 1 salary for a New Bedford resident. Otherwise, she will not accept the position, and we are likely to have difficulty finding another suitable candidate.

Ms. Paul and Ms. Cohen will be available at the meeting to answer any questions you may have.

Dear Mayor Mitchell:

I am excited to recommend Courtney Cohen for the position of Environmental Project Manager. After an exhaustive search, during which the only other two qualified candidates ultimately withdrew their names from consideration, Courtney was selected as the only remaining qualified candidate, and she is highly qualified, though she resides out of town. Courtney lives with her family in South Dartmouth, just over a mile from New Bedford. She has children who attend Dartmouth Public Schools and her parents who also live nearby in Dartmouth provide much of the Cohens' support network. I recognize that the recently-modified Residency Ordinance requires any non-resident employee to accept a 10% reduction in pay for the first 10 years of service. Were Courtney to begin at a Step 1, the 10% penalty would prevent her from being financially able to accept the position.

Courtney has a Bachelor's Degree in Civil and Environmental Engineering and is uniquely qualified with experience in local, state, and federal environmental regulations including the Massachusetts Contingency Plan. She has worked in and around New Bedford for twenty years and is very familiar with its environmental assets and challenges. With five active EPA Brownfield grant programs and a multi-year cleanup of the AVX site underway, it is certainly in the City's best interest to fill this key position with a candidate with the proper experience and management skillset. I am hopeful that you will support a request to the City Council that given Courtney's 20 years of professional experience and qualifications suited to the position of Environmental Project Manager, she be onboarded at a Step 4. This will still result in a starting salary 2% below the full Step 1 rate and a cost savings to the City.
