The Committee on Ordinances at a Meeting held on Wednesday, September 22, 2021, considered a COMMUNICATION, Mayor Mitchell, to City Council, submitting AN ORDINANCE, amending Chapter 17, Offenses and Miscellaneous Provisions, subjecting violators of Chapter 12, Section 12-41.1 – Duty of Property Owners to Maintain Yard and Adjacent Areas to a graduated fine regime, and adding the offenses and associated fines to Section 17-18, Noncriminal Disposition of Violations of Certain Ordinances, Rules and Regulations; AND, Section 17-28, Chapter 40U of the Massachusetts General Laws. (Ref'd 04/08/2021)

On motion by Councillor Lopes and seconded by Councillor Markey, the Committee VOTED: To recommend to the City Council ADOPTION of AN ORDINANCE, amending Chapter 17, Offenses and Miscellaneous Provisions, subjecting violators of Chapter 12, Section 12-41.1 – Duty of Property Owners to Maintain Yard and Adjacent Areas to a graduated fine regime, and adding the offenses and associated fines to Section 17-18, Noncriminal Disposition of Violations of Certain Ordinances, Rules and Regulations; AND, Section 17-28, Chapter 40U of the Massachusetts General Laws.
