The Inspectional Services Department is requesting to transfer \$36,300.00 from our 100 Account Salary & Wages (02400000-511110) to our 200 Account Charges & Services-Contractual line (02400000-520330). We are looking to contract out for a Permit Consultant (\$18,900) and a Per Diem Wire Inspector (\$17,400). There is surplus in our 100 Account due to the vacant position of the Deputy Commissioner.

The Permit Consultant is needed to help the Commissioner with the numerous permits that are being issued. We unfortunately have not had very many applicants apply for the Deputy Commissioner position and this contractor will be able to perform some of the duties of the Deputy Commissioner.

The Per Diem Wire Inspector contractor is necessary if the Wire Inspector should need to be out for any extended period of time. A few months back the Wire Inspector was out for several weeks do an illness and we had to have an outside contractor perform some emergency inspections for. By having this MOA in place it will eliminate any problems should we need to use the Per Diem Wire Inspector.
