

Referenced herein is a request to the City Council to utilize a portion of the undesignated fund balance for the Senior Travel Program (Fund #1238) in the amount of **FIFTEEN THOUSAND (\$15,000.00) DOLLARS** for a total of **ONE HUNDRED TWENTY SEVEN THOUSAND (\$127,000.00) DOLLARS** in FY16.

The Senior Travel Program has traditionally operated long distance/overnight trips for large groups of seniors. It has a great following and sells out for each trip the Coordinator books.

The requested funding would cover the balance of trips booked for the remainder of FY16, including a large trip to Niagara Falls.
