Dear Council President Abreu and Honorable Members of the City Council:

I am pleased to submit for your confirmation the appointment of Gary Lunsford as Director of Zoological Services with the City of New Bedford Buttonwood Park Zoo. Mr. Lunsford is a seasoned professional in the zoological field and the current Director of Animal Management and Health at the Milwaukee County Zoo.

Mr. Lunsford has over thirty years of experience in animal care and over twenty years of experience in accredited zoological parks. In his current position, he has implemented strategic initiatives and provided executive leadership to a 190-acre zoo that houses over 2,100 animals and 348 species.

Mr. Lunsford is an active member of the Association of Zoos and Aquariums, the Zoological Registrar's Association, as well as several other groups. In sum, Mr. Lunsford is the most qualified candidate for the job, having amply demonstrated his indepth knowledge of zoological practices and animal care, his leadership experience, and his passion for preserving the future of wildlife.

At this time, I am also respectfully requesting that Mr. Lunsford be established at Grade M-16, Salary Step 6 (\$107,476) on the Unit C Salary Schedule. Please be advised that the Buttonwood Park Zoological Society has committed to helping the City defray the cost of the Director's position by funding the difference between Grade M-16, Step 1 (\$93,616) and the Grade M-16, Step 6 salary being proposed--or approximately 12.5% of the Director's salary. This same arrangement served the City well during the former Zoo Director's tenure, and I am pleased to report the continuation of the Zoological Society's funding commitment.
