RE: RFR. #22130143 Vacant or Abandoned Property Rehabilitation

Dear Members of the New Bedford City Council,

We, Members of the Community, write to express our grave concerns with the 90-day response time for *Request For Response*, (RFR) 22130143, Vacant or Abandoned Property

Rehabilitation and request the full support of the New Bedford City Council in our request for, at minimum, a twelve month extension to respond and our request for a supervised bus tour of the City of New Bedford's HUD-designated Qualified Census Tracts (QCT). RFR 22130143 is intended to be funded by the American Rescue Plan Act, federal award number SLFRP1067, awarded to the City of New Bedford (City) by the U.S. Department of the Treasury (Treasury).

Recent census data analysis demonstrates that over the past decade, there is a noticeable decrease in the population of Cape-Verdean Americans residing in the City of New Bedford's HUD-designated Qualified Census Tracts (QCT) and in the City of New Bedford overall. Whether unintended, RFR 2213014, will have consequences that will weaken the present community culture and very likely result in further gentrification of the New Bedford-Cape Verdean community.

We recognize the blight vacant and abandoned properties have in our neighborhoods and align with the effort to address the matter. As a community directly impacted by the HUD-designated QCT, it is important that barriers are not erected that will weaken the intended beneficiaries.

Additional time is needed to adequately prepare a comprehensive and competitive response and for these reasons and as part of our community oversight duties, we ask that you support, at minimum, a 12-month extension to respond to RFR 22130143 and support our request for a supervised bus tour of the City of New Bedford's HUD-designated Qualified Census Tracts (QCT). We, the undersigned Members of the Community, request the support of the New Bedford City Council as we ask the mayor to swiftly answer our request and as we ask the mayor for his cooperation and full transparency in the execution of RFR. #22130143 Vacant or Abandoned Property Rehabilitation.
