## 17.244 AN ORDINANCE

## TO ESTABLISH A MINIMUM WAGE FOR MUNICIPAL EMPLOYEES

An Ordinance of the City of Northampton, Massachusetts. Be it ordained by the City Council of the City of Northampton, in City Council assembled, as follows:

1	SECTION 1

3	That the Code of Ordinances be amended by adding the following:

5	§ 5-6 Fair Minimum Wage Ordinance
6	
7	No executive or legislative branch employee of the City of Northampton shall
8	be paid at a rate less than the minimum wage set forth in the Massachusetts
9	Minimum Fair Wage Law, MGL Chapter 151 Section 1. Nothing herein shall
0	be construed to apply to any wages established pursuant to an existing
1	collective bargaining agreement or to the compensation of any elected
2	official.
