Re: Award of School Transportation Bids and Contracts for 2023 - 2026 School Years as Required under Chapter 30B § 12(b) for Contracts in Excess of Three (3) Years

Dear Mayor Mitchell,

Following a successful public bidding process, this memorandum asks that the City Council authorize the award of the three school bus transportation contracts for the 2023 - 2026 school years with two, one year options for renewal, as required by MG.L. Chapter 30B § 12(b) which states, *"Unless authorized by majority vote, a procurement officer shall not award a contract for a term exceeding three years, including any renewal, extension, or option."*

The City of New Bedford School Department, through the City's Purchasing Department, bid three separate packages for Student Transportation Services for a term of three years, with two, one-year options to renew (known as a 3+1+1 contract.)

The following are the results of those bids:

Student Transportation Package One: Package One consists of two bus routes; one route utilizing 8 single tier bus routes, the the other utilizing 14 double tier bus routes. One bid was received for these services with the following bid results:

Student Transportation Package Two: Package Two consists of two bus routes; one route utilizing 2 single tier bus routes, the other utilizing 16 double tier bus routes. One bid was received for the services with the following bid results:

Student Transportation Package Three: Special Education/McKinney Vento Transportation consists of single tier and double tier bus/van routes both in-district and out of district. One bid was received for the services with the following results:
