Dear Council President Morad and Honorable Members:



Dear Mayor Mitchell

As you know, the Solicitor's Office has had vacancies in its two Associate City Solicitor positions for over a year and the Department's full-time personnel have operated in that time at half capacity. First Assistant City Solicitor Liz McNamara and I interviewed seven qualified candidates to fill the vacancies. Recently, I have been able to offer a qualified candidate for one of the two vacant positions employment at M-15, Step 1 which salary the candidate has agreed to accept.


I also have an extremely experienced and well qualified candidate for the second vacant Associate City Solicitor position. In order to induce that candidate to accept the position I would ask that you request that the City Council, pursuant to the Code of Ordinances Section 19-7.1(c), authorize the negotiation of the salary for that position at M-15 and a Step of 1, 2, or 3 upon initial hire up to and including June 30, 2023.

In addition to many years in civil practice, this second candidate has served as the City Solicitor for a Massachusetts city for fifteen years (after several as a Land Use Planner and Attorney there), and more recently has also served as Town Counsel for a Massachusetts town for four years. The candidate has provided wide-ranging legal analysis in these municipal legal offices, advising on litigation, contracts, procurement, tax takings, ordinances, zoning and real estate, and more. This attorney's expertise will serve as a force multiplier in the New Bedford City Solicitor's Office, and the attorney's broad range of municipal legal experience will allow the candidate to excellently advise the City as a whole.

Because of these decades of municipal legal experience, I am requesting that this candidate be initially placed at Grade M-15, Step 1, 2 or 3. Of the available steps, the Step 3 salary would most accurately value the attorney's experience and expertise for the City.
