## Memorandum of Agreement Between

### The City of New Bedford and American Federation of State, County, and Municipal Employees (AFSCME), AFL-CIO, Council 93

#### April 10, 2023

This Memorandum of Agreement was reached in off-the-record negotiations and shall remain off the record for all purposes, including bargaining history, until it is ratified by the Union membership, approved by the Mayor, and funded by the City Council.

The City of New Bedford ("City") and the American Federation of State, County, and Municipal Employees, AFL-CIO, Council 93 ("Union" or "AFSCME"), agree to a collective bargaining agreement ("CBA") from July 1, 2022 through June 30, 2025 with the following terms. All existing provisions in the parties' July 1, 2020 – June 30, 2023 CBA not expressly amended or deleted by this Memorandum of Agreement shall be included in the July 1, 2022 – June 30, 2025 CBA.

#### 1. Amend Article XVI (Classification and Compensation Plan):

#### Strike existing Section 1 and replace with the following:

#### 1. Section 1A. Wages

Effective Upon Ratification 1% salary increase Effective July 1, 2023 2% salary increase Effective July 1, 2024 2% salary increase

#### 2. Section 1B. Salary Scales

i. Effective upon ratification, Step 1 of the pay scales will be deleted.

Effective upon ratification, a new top step shall be created at 3% higher than the then existing top step.

All employees currently employed upon ratification, will step to the next step, with the date of ratification becoming their new step date.

Thereafter the scales shall be renumbered Step 1 through 10.

ii. Effective July 1, 2023, the then-existing Step 1 on the pay scales will be deleted.

#### 2. **Modify Article XIX (Protection):** add new language as follows:

Effective July 1, 2024, employees in designated (List to be Attached as "Attachment A to this MOA") positions within Airport, Traffic, DFFM, DPI, and Zoo who are required to wear safety shoes and/or boots for their work may be entitled to up to a one hundred dollar (\$100) annual reimbursement upon proof of purchase of said shoes and/or boots. Proof of purchase must be submitted to Department designee for approval and said purchase must have occurred within the same fiscal year.

Effective upon funding, the City agrees to purchase winter jackets and rain gear for Parking Enforcement Officers and Meter Repairmen. The gear shall remain the property of the City.

# 3. <u>Amend Article XVII (Longevity) as follows</u> (old language struck, new language underlined):

Those employees employed with ten (10) through fourteen (14) years of service as of November 30 of the calendar year shall receive four hundred fifty five hundred (\$450500) dollars per year.

Those employees employed with fifteen (15) through nineteen (19) years of service as of November 30 of the calendar year shall receive five hundred fifty six hundred (\$550600) dollars per year.

Those employees employed with twenty (20) years through twenty-four (24) years of service as of November 30 of the calendar year shall receive six seven hundred fifty (\$650700) dollars per year.

Those employees employed with twenty-five (25) through twenty-nine (29) years of service as of November 30 of the calendar year shall receive seven eight hundred fifty (\$750800) dollars per year.

Those employees employed with more than thirty (30) years of service as of November 30 of the calendar year shall receive eight nine hundred fifty (\$850900) dollars.

Those employees with more than thirty-five (35) years of service as of November 30 of the calendar year shall receive one thousand  $\underline{\text{fifty}}$  (\$1,00050) dollars.

#### 4. Article IV (Seniority)

#### SECTION 1.

In all cases in which the Employer promotes employees within the bargaining unit from a list of employees eligible for promotion, which list is issued under the provisions of

The Employer shall provide to the Union an updated listing of codes on a weekly/bi-weekly/monthly basis. If, however an existing code is changed or created, or changed and applied to an employee, the Employer shall provide to the Union a notice of said change(s) made to an existing code or created code within thirty (30) days of said change.

#### **Health Insurance and Dental Premiums**

The City shall bi-weekly deduct the employee's share of health insurance and life insurance premiums, dental insurance and any fees or assessments from the earned wages of each employee in such amount as determined by the Union provided that no such deduction shall be made from any employee's wages except when authorized by the employee on an appropriate form, a copy of which must

absence (such as vacation, long-term leave, previously scheduled sick day) or provides medical documentation supporting their need to decline.

#### 3. Amend Article XVIII (Holidays) to include:

Juneteenth

#### 4. Amend Article XXIX (Performance Evaluation), Section 9 as follows:

Strike all references to "American Arbitration Association" and replace with the "Labor Relations Connection."

#### **Housekeeping**

#### 5. Amend Article III (Grievance and Arbitration Procedure) as follows:

• Modify Step 2 as Follows (new language underlined):

If the Grievance remains unsettled, it shall be presented to the Director of Labor Relations and Personnel, acting for the Mayor, in writing within five (5) working days after the response of the Department Head is due. <u>Grievances involving disciplinary action shall be processed beginning at the second step.</u> The Director shall respond in writing within thirty (30) working days of the presentation of the grievance. Failure by the Director to reply within this period shall be construed as a decision favorable to the employee.

• Add New Subheading, which will be reflected in the CBA's Table of Contents, before final 2 paragraphs of the Article as follows (new language underlined):

#### **Discipline and Discharge**

When an employee covered by this Agreement is suspended for any reason by the employee's supervisor or Department Head, said employee shall be given notice in writing of the suspension, together with an explanation of the reason(s) therefore. Copies of such notices must also be provided to the employee's union steward and the union president.

At least forty-eight (48) hours shall be allowed from the time of filing of the notice with the Union before such suspension may be placed in effect, during which time the Union shall attempt to settle the difficulty with the suspending authority; except that in cases in which the cause for suspension involves acts of violence, acts commonly considered to be of a criminal nature, or acts endangering property and/or the safety of fellow employees or the public, such suspension may be implemented and the

#### Side Letter of Agreement

#### Between the City of New Bedford

#### And

#### AFSCME Council 93, Local 851, Unit A

April 21, 2023

WHEREAS the City of New Bedford ("City") and AFSCME Council 93, Local 851, Unit A ("Union"), collectively referred to as the "Parties," completed bargaining over the impacts of Emergency Telecommunications Dispatchers (hereinafter referred to as "Dispatchers") represented by the Union receiving calls and dispatching calls for response by the fire department;

WHEREAS, recently the City has had a number of resignations of Dispatchers; and WHEREAS, the Parties share an interest in the retention of Dispatchers; NOW THEREFORE, the Parties agree as follows:

- 1. Effective April 24, 2023, Emergency Telecommunications Dispatcher shall be moved to Grade K in Attachment D of the Parties' collective bargaining agreement. Existing employees will move step for step, meaning an employee currently on Step 5 of the existing Grade would be moved to Step 5 of Grade K.
- 2. Notwithstanding the above, Dispatchers will still be entitled to any wage and/or step increases that may result through successor bargaining between the parties' regarding the collective bargaining agreement that expired on July 1, 2022.
- 3. The Union acknowledges that the City satisfied all bargaining obligations associated with Dispatchers handling all fire-related calls including taking calls for fire services and for dispatching fire services. Dispatchers will receive training prior to handling fire-related calls.
- 4. This side letter of agreement shall remain off the record for all purposes until it is approved by the Union and the Mayor and funded by the City Council.

This Side Letter of Agreement is subject to approval by the Mayor and the Union, and funding by the City Council. Subject to the prior sentence, this Side Letter of Agreement is agreed to by the Parties on the date(s) indicated below:
